# "AN ORDINANCE OF THE VILLAGE OF LOCH LLOYD, MISSOURI, DECLARING THE RESULTS OF THE APRIL 8, 2025, ELECTION."

WHEREAS, a general municipal election was held on April 8, 2025; and

WHEREAS, the Board of Trustees is obligated to declare the election results at the next regularly scheduled Council meeting following the election; and

WHEREAS, Section 80.060 of the Revised Statutes of Missouri requires that the Board of Trustees assemble within twenty (20) days after an election to be sworn in, and for a Clerk and Chairperson to be elected.

## NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF LOCH LLOYD, MISSOURI, AS FOLLOWS:

<u>Section 1.</u> It is hereby found and determined by a canvass of the votes by the Board of Trustees of the Village of Loch Lloyd, Missouri, at the election held on April 8, 2025, in conformity with the Comprehensive Election Act of 1977; Revised Statutes of Missouri; and the Ordinances of the Village of Loch Lloyd, Missouri, as follows:

<u>Section 3.</u> Severability. If any section, subsection, sentence, clause, phrase, or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

<u>Section 4.</u> Effective Date. The effective date of approval of this Ordinance shall be coincidental with the Chairman's signature and attestation by the Village Clerk.
