VILLAGE OF LOCH LLOYD VILLAGE CLERK CALLS FOR SPECIAL ELECTION FOR BOARD OF TRUSTEE MEMBER

(VILLAGE OF LOCH LLOYD, MO) – The Village of Loch Lloyd Village Clerk issued the following proclamation following a tie during the April 8, 2025, election for Board of Trustee Member. The Village Clerk has ordered a special election to be held Tuesday, June 3, 2025.

A copy of the proclamation, as well as a copy of the form of the Notice of Election, are attached.

The proclamation reads:

"WHEREAS, on April 8, 2025, a general municipal election was held in the Village of Loch Lloyd, Missouri, to elect three (3) at-large members of the Board of Trustees; and

WHEREAS, the ballot for the April 8, 2025 election of the at-large members of the Board of Trustees was formatted and presented to the electorate as follows:

WHEREAS, the votes case in the election for one (1) of the three (3) Board of Trustee positions resulted in a two-way tie vote for one (1) of the open seats between Chuck Etherington and Ruth Withey, as set forth in the certification of election results issued by the Cass County Clerk / Election Authority, which is attached hereto, and incorporated by reference herein as Exhibit "A"; and

WHEREAS, neither of the candidates have requested a recount of the votes cast at the village election for the remaining open seat by the Cass County Clerk / Election Authority; and

WHEREAS, Section 115.517.3 RSMo provides that the officer with whom such candidates filed their declaration of candidacy shall issue a proclamation stating the fact there were an equal number of votes cast for election to the office and order a special election to determine which candidate is elected to the office unless the candidates agree to the alternative procedures set forth in Section 115.517.4 RSMo; and

WHEREAS, the candidates have not agreed to the alternative procedure authorized by Section 115.517.4 RSMo; and

WHEREAS, the Village Clerk is the officer with whom the candidates for the Board of Trustees filed their declaration of candidacy in the Village of Loch Lloyd, Missouri.

NOW THEREFORE, I, Anthony Lafata, Village Clerk for the Village of Loch Lloyd, Missouri, do hereby issue this proclamation declaring an equal number of votes were cast for one (1) of the three (3) open seats for the Board of Trustees at the April 8, 2025 village election, and order a special election to be conducted by the County Clerk / Election Authority in and for the County of Cass, State of Missouri, on Tuesday June 3, 2025, for the remaining open seat on the Board of Trustees; and

FURTHER, the special election called for herein shall follow the same rules as the Village election held on April 8, 2025, registration shall close on May 7, 2025 pursuant to

Section 115.135 RSMo, with excuse absentee voting by mail, or in person at Harrisonville, starting on April 22, 2025, and no excuse voting in person at Harrisonville, starting on May 20, 2025; and

FURTHER, the candidates to be voted on at such election shall be Chuck Etherington and Ruth Withey. The special election shall be conducted and the votes counted as in other elections. The form of the Notice of Election shall be substantially as set forth in Exhibit "B' attached hereto and incorporated herein.
